## Change/Disconnect Service Agreement

It is the policy of Tuckaleechee Utility Department to require that the applicant seeking change or discontinuation of service be the responsible and current account holder currently residing at the service address. No other persons except the current account holder or property owner/landlord will be eligible to make any changes to the account. This includes, but not limited to name change, transfer of service or discontinuation or disconnection of service.

Whenever an application is made for a change or discontinuation of service, any and all accounts involved MUST be brought current prior to any changes being made. Applicant is also aware that there may be additional applicable fees involved, depending on the type of service change requested. All requests **must be made in person** at Tuckaleechee Utility Department located at 7706 Chestnut Hill Road in Townsend Tennessee or by fax and proper documentation, such as a photo id or drivers license will be required at the time of the request.
